Enclosed is a copy of the "Temporary Food Stand Guidelines" from the Iowa Department of Health. All food booth operators **MUST** follow these guidelines. Profit organizations will be required to obtain an additional license for the price of \$25. Inspectors will be on hand that morning and noncompliance will result in your booth being shut down. If you have questions regarding these guidelines, please contact our office.

A list of last year's food booth participants is enclosed. We invite you to offer the same choices as last year, or add some new and different food/drink choices this year. Food booth participants from last year will receive first choice for the food/drink sold this year; other requests will be received on a first-come, first-serve basis to help eliminate duplication of booths.
